HOUSING –

1. **The Cook County Sheriff's Office has suspended all court-ordered evictions for the next 30 days AS OF MARCH 14.** The suspension is in response to an order from the Office of the Chief Judge issued late Friday evening. No one, regardless of legal citizenship or not, can be evicted at this time across Illinois.
 - a. If you are being harrassed for rent, tell the landlord that you know that you cannot be evicted at this time.
 - b. Ask for a payment plan.
 - c. Ask that the landlord stop calling or visiting to request payment. If the landlord continues to call or visit, call 911 as this is harrassment. NOTE: You must first tell the landlord to stop calling or visiting in order for this to constitute as harrassment.

UTILITIES:

1. [Illinois Commerce Commission](#) has ordered all public gas, electricity, water and sewage utilities in the State of Illinois to cease disconnections and waive late fees until May 1, or until the state of emergency is lifted. This order does not apply to municipal-owned utilities or cooperatives, but several of those have decided to institute similar policies. Find a list of non-municipal Illinois utilities [here](#).
2. [Comed](#) has suspended disconnects for residential and commercial customers unable to pay their bills and are waiving new late payment charges through at least May 1st. Comed will work with customers on a case-by-case basis to establish payment arrangements and will offer flexible payment plans to customers who indicate either an impact or hardship as a result of COVID-19. 3. [People's Gas](#) has suspended shut offs for residential and business customers, unless unsafe conditions exist. People's Gas is also waiving new late payment charges. If customers are having difficulty paying their bill, People's Gas will work with them to arrange a payment plan or discuss financial assistance options. Customers can call (866) 556-6001.
4. [NicorGas](#) has suspended service disconnections for non-payment, effective immediately for both residential and commercial customers through May 1st.

UNEMPLOYMENT INSURANCE:

1. Undocumented workers are not eligible for unemployment insurance. However, they can sign up for disability benefits if injured at work. SSDI at:

2. **DACA recipients are eligible to file for benefits as long as they have a current authorization to work.** They can enter the card information during the claim filing process online (www.IDES.Illinois.gov), once the claim is filed they are asked to submit copies of the I-766 (work Authorization card) for further review. The individual needs to have proof of legal authorization to work during the base period that is used to establish the unemployment claim.

In order to process the extremely high volume of unemployment benefit claims due to COVID-19, IDES has implemented the following schedule for those filing claims online and over the phone:

Online Filing Schedule: Online filing and claims applications will be unavailable every night from 8 p.m. to 10 p.m. for daily claims processing.

- Last names beginning with letters A-M can file their claims on Sundays, Tuesdays, or Thursdays.

- Last names beginning with letters N-Z can file their claims on Mondays, Wednesday, Fridays.
- Saturdays will be available for anyone.

Call Center Filing Schedule: 7:30 am to 6 pm

- Last names beginning with letters A-M can call on Tuesdays and Thursdays
- Last names beginning with letters N-Z can call on Mondays and Wednesdays
- Fridays will be available for anyone
